A copy of the report on the existing condition of the
Asansol H.S. Railway High School, in the District of Burdwan,
drawn up by the ~~Assistant~~/District Inspector of
Schools Burdwan together with necessary statement and
sketch map, all in duplicate, is enclosed herewith. The School
was a permanently recognized one. It was granted permanent
recognition 1899 by the Calcutta University
and it has been enjoying the privilege of permanent recognition.

It will be seen from the report that the major conditions
as required for permanent recognition have ~~not~~ been fulfilled by
the authorities of the school. Therefore recommend that
the privilege of permanent recognition enjoyed by the School be
withdrawn. The school should be recognized for a period of
Five years with effect from January, 1955 on the
following conditions :-

1. The school should be inspected by the Inspector of Schools.
2. The school should be provided with teachers should be deputed to a
training course of training with Geography as
their subject.
